- b. Conservation District Overlay Discussion of overlay to protect character of neighborhoods in discussed area. The idea is rather than building a structure that is totally out of character with the entire neighborhoods, that they would have some guidelines that staff would be able to give them. They could choose from a variety of designs that they would see right there at the Planning Department counter. Chair Warren suggested the following styles:
 - Tudor
 - Victorian
 - American Colonial
 - Art Deco
 - Craftsman
 - California Spanish Stucco
 - Mid-Century Modern
 - 1940's Bungalow (added by staff)

Work needs to be done to define each style in a clear and objective way, with photos.

The language for the design overlay needs to address the situation where the existing home doesn't fit within the finalized categories, the addition will reflect the existing house through size, scale, number of windows, etc.

It would be important to consider allowing maintenance and updates of existing more modern homes without fully converting a home to a historic style. New construction or remodeling of existing houses should be consistent with the existing style.

Ryan mentioned that he can get copies of guidelines from Bend and Jacksonville for the HBSC to review.
