**CRITERIA FOR APPROVAL:** The City Council may approve, approve with modifications, or deny the proposal based on the criteria found in Sections 5.052 and 5.053 of the City of Grants Pass Development Code. Annexations approved by City Council will be forwarded for a vote by city electors on the November 4, 2014 ballot in accordance with the City Charter.

**OBTAINING MORE INFORMATION:** A copy of all documents and the applicable criteria will be available at the City Planning Division office. A copy of the staff report will be available at least seven days prior to the City Council hearing. All documents may be inspected at no cost and will be provided at reasonable cost. The City Planning Division office is located in Room 201 of the City of Grants Pass Municipal Building, 101 NW 'A' Street, Grants Pass, OR 97526. The office is open 8:00am to 5:00pm on regular business days. If you have questions, contact the office in person or at (541) 450-6060.

**COMMENTING ON THE PROPOSAL:** The Planning Commission hearing provides an additional opportunity to receive testimony for the record in advance of the City Council hearing. The Planning Commission will not make a decision or a recommendation to the City Council, but will receive oral and written testimony concerning this proposal. The testimony provided at the Planning Commission hearing will be forwarded to the City Council as part of the record to consider when making their decision.

At the hearings, the Planning Commission and City Council will take oral and written testimony concerning this proposal in accordance with legislative hearing guidelines in GPDC Article 9. Written testimony may be presented at the hearing, or may be submitted to the City of Grants Pass Planning Division office any time between now and 5:00pm on the date of the hearing. Failure of an issue to be raised in the meeting, in person or by letter, or failure to provide statements or evidence sufficient to afford the decision maker an opportunity to respond to the issue precludes appeal to the State Land Use Board of Appeals based on that issue.
